Item no-2	Supplying and drawing of UTP 4 pair CAT 6 LAN cable (Di-Link) in the existing Surface/recessed steel/PVC conduit as required	1500 Mtr.	@ Rs.	Rs.

Terms and Conditions:

1. Work should be completed within 15 days.
2. C.P.W.D specification will be followed strictly.
3. Executive Director, SOL reserves the right to reject any or all quotation without assigning any reason whatsoever.

4. Should the work be not completed to the satisfaction of the SOL within the stipulated period, the Contractor shall be bound to pay to the SOL, a sum calculated @ 0.5% of the Contract value for per week of delay subject to a maximum of 10% of the contract value by way of liquidated damages during which time the work remains uncommenced or unfinished after expiry of completion date.
5. Rates should be quoted both in words and figures.
6. The Contractor should visit the site before quoted their rates.
7. The site shall be cleared of all loose material.
8. The contractor or his representative should be made available at the work site during the execution of the work.
9. Electricity required for the work will be allowed to the contractor for use and 1.5% of the full cost of the work executed, will be recovered
10. The contractor shall have to get the site of work cleared during execution and / or on completion of work as per directions and to the satisfaction of the committee/SOL authority.
11. Sample of the material should be approved from the Monitoring Committee before using at site.
