Dear Sir,

This has reference to your application requesting Distance Education Council for post facto recognition of programmes offered through distance mode / non formal mode by the University of Delhi, Delhi.

In this connection, we would like to inform you that to safeguard the interest of the students of University of Delhi who have already completed the courses during the period 1.3.1995 to 31.5.2008, the Chairman, Distance Education Council has accorded post-facto recognition to your University, as a provisional measure, for the following programmes offered through distance mode with effect from 1st March, 1995 to academic year 31.5.2008.

1. Bachelor of Arts (BA)
2. Bachelor of Arts (Honours) in English
3. Bachelor of Arts (Honours) in Political Science
4. Bachelor of Commerce
5. Bachelor of Commerce (Honours)
6. Master of Arts (MA) in Hindi
7. Master of Arts (MA) in History
8. Master of Arts (MA) in Political Science
9. Master of Arts (MA) in Sanskrit
10. Master of Commerce

Prior to March 1995, there was no system for giving recognition to distance education programmes and therefore the issue of post-facto approval for such courses during that period does not arise. The certificates issued by the University stand automatically recognized if they were approved by the relevant statutory authorities of the University. It may be noted that any degree/diploma/certificate offered through a franchising agency by the university does not have the approval of Distance Education Council.

Further, you are requested to apply to the DEC on the prescribed format for the regular recognition of your programmes offered through distance education mode beyond 31.5.2008.
